

Can the export of photovoltaic panels be tax-refunded



Overview

Starting April, the value-added tax (VAT) export rebates for PV products will be completely eliminated. This decision follows a previous reduction from 13% to 9% in December 2024. Export tax rebates are financial incentives provided by governments to encourage exports by refunding a portion of the taxes paid on goods sold abroad. In the context of the photovoltaic industry, these rebates have historically helped Chinese manufacturers maintain competitive pricing in China. China announced on Friday that it will change export tax rebates for a range of products, including photovoltaic and battery products. The announcement, jointly issued by the Ministry of Finance and the State Taxation Administration, said that export tax rebates for the value added tax of Beijing's decision to eliminate solar export VAT rebates tackles deep structural problems: massive oversupply, unsustainable pricing, and growing trade tensions. single items) may affect the tax refund rate. This move will significantly impact processing enterprises. For example, aluminum processors currently earn 27,709 yuan per metric ton, including a 13% tax rebate of 2,859 yuan.

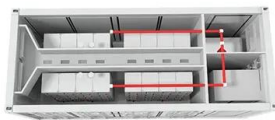
