

# Copenhagen EK SOLAR wind power with energy storage



## Overview

---

Danish renewable energy developer Copenhagen Energy has partnered with a local electricity and fibre network distributor Thy-Mors Energi to set up a 100MW PV and battery energy storage system (BESS) project in Ballerum, about 370km from Copenhagen. Ørsted, the global leader in offshore wind, has signed an agreement with Copenhagen Infrastructure Partners (CIP), through its fifth flagship fund, Copenhagen Infrastructure V (CI V), to divest its entire European onshore business. The total value of the transaction is EUR 1.44 billion, with expected closing in Q2 2026 subject to regulatory approval, marking the completion of its previously announced divestment programme alongside. The Kvosted energy park combines large-scale solar generation with a 200 MWh battery system in Denmark, enabling electricity storage, grid balancing and improved asset economics.
