Overview

The Trump administration was sued by some two dozen states that are seeking to block the Environmental Protection Agency (EPA) from canceling a \$7 billion solar energy program. 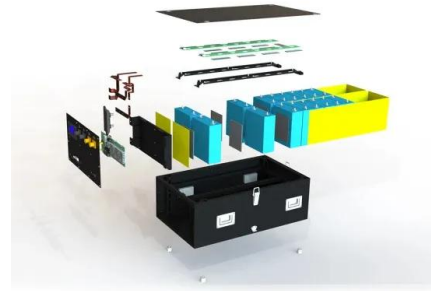
